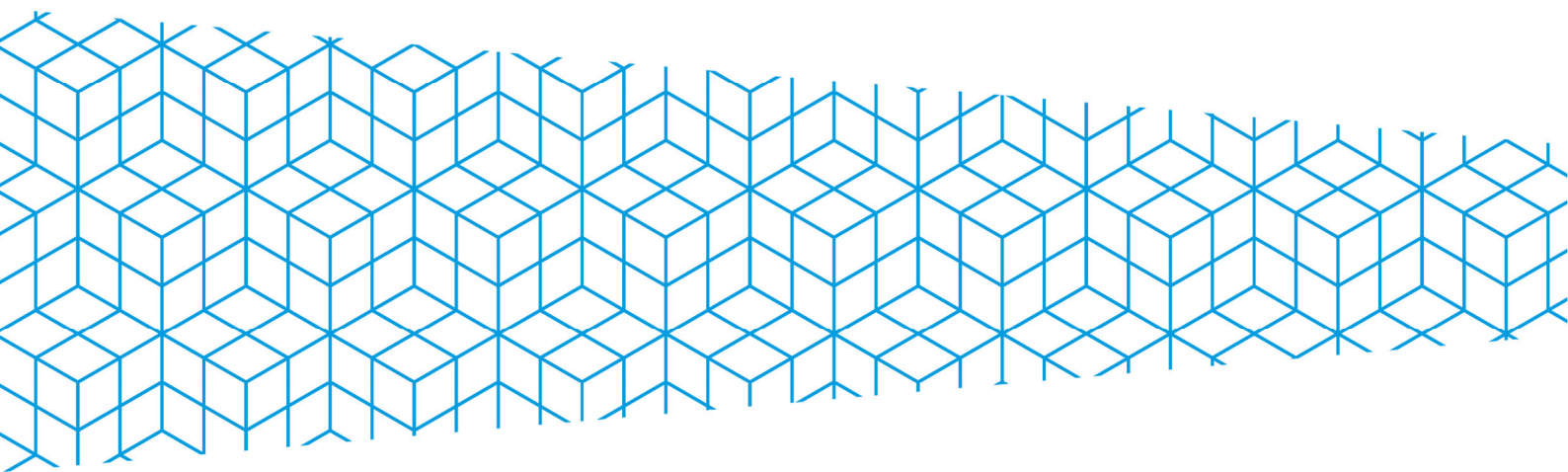


Guide for incoming exchange students

Language level

Most of the courses offered at the Faculty of Law and Political Science are taught in French.

The minimum required language level is B1 (CEFR), but a B2 level or higher is strongly recommended.

A B2 level is required to take courses taught in English.

WARNING: Students who wish to enroll in the Certificat de Droit Français (French Law Certificate) must provide proof of a B2 level.

French as Foreign Language (FLE) courses are available free of charge throughout the year. These courses begin with an intensive session which usually starts a week before the beginning of law classes (2 to 3 hours per day, every day). They continue with an extensive session during the semester (2 hours per week). Students enrolled in these courses can receive credits if they pass the exams.

Both the intensive and extensive sessions must be completed in order to receive credits.

Buddy program

The University of Bordeaux offers a buddy program to help international students integrate more easily.

Administrative registration

Students selected to study at the Faculty of Law and Political Science can choose from two academic tracks :

- *Étape créditable* (ECTS) (credit-earning track): the student selects « à la carte » courses among those offered to exchange students
- *Certificat de Droit Français* (CDF) (Certificate in French Law) : this certificate is open to full-year exchange students who can demonstrate a minimum B2 level in French.

Administrative registration must be completed online before arrival. The international mobility office will send the required information to students in July (for the 1st semester) or in November (for the 2nd semester).

Exchange students are exempt from tuition fees and the CVEC (Student and Campus Life Contribution).

Students must upload the following documents online :

- Photocopy of passport or ID card
- ID photo
- Data usage authorization form (to be downloaded in Step 3 : [Dépôt des pièces justificatives](#))

Digital Identity (IDNUM)

The digital identity allows access to the digital services and applications of the University of Bordeaux. It can be used after activation. This activation makes it possible to obtain your personal username and choose your personal password. Activation will be available 24 hours after administrative registration at the University via the following address : <https://idnum.u-bordeaux.fr/etudiant>

Module registration

There are two types of courses :

- Courses with tutorials (TD). These courses have two components :
 - o Lectures (CM) : taught in a lecture hall or large classroom
 - o Tutorial (TD) : Weekly 1.5-hour sessions in small groups with a teaching assistant to deepend the concepts covered during the lectures. Active participation is expected. There's a strong focus on legal methodology. Attendance is mandatory and absences must be justified (e.g., medical certificate). If a student has 3 unexcused absences, he/she will receive a 0/20 (Fail) for the TD. For language TDs, 2 unjustified absences result in a 0/20. Depending on the subject, there are 5 to 10 sessions per semester.

- Optional courses (without TD). These courses consist only of lectures (CM).

Due to large student numbers, each undergraduate year is divided into two groups :

- o Year 1 and Year 2 (L1 & L2) : Série 1 and Série 2
- o Year 3 (L3) : Group 1 and Group 2

Learning agreement

Before the mobility :

As part of their application, students must fill out a learning agreement (LA) with the courses they plan to take in Bordeaux. This LA must be approved by the coordinator at their home university.

Once the application is received, the Faculty's International Mobility Office will review the learning agreement (course selection) and return it to the students by June (for the 1st semester) or December (for the 2nd semester).

Students are limited to 35 ECTS per semestre (French as foreign language classes included).

Erasmus students are required to complete their OLA (Online Learning Agreement) on the platform used by their home university. The following information is necessary to fill in the form :

During the mobility :

Upon arrival, students have 1 to 2 weeks from the start of classes to change their learning agreement. After this period, students must submit their final learning agreement to the International Mobility Office of the Faculty of Law and Political Science to proceed with their module registration. The new learning agreement will be signed by the coordinator and returned to the students who will be required to submit it to their home coordinator for approval.

Students wishing to take modules with TD or language TDs are asked to contact the International Office during the first week of classes to be placed in TD groups.

Examinations

An exam session is organized each semester :

- 1st semester exams take place in December / January
- 2nd semester exams take place in May (undergraduate courses) and May/June (Master 1 courses). Please refer to the academic calendar.

A resit session is held in June / ealy July for undergraduate courses only.

There is no resit session for Master courses (single exam session)

The type of exam depends on the course and year level. Please refer to the course catalogue.

Students must register for the resit session if they want to retake failed exams. The International Mobility Office will contact the students after the first session results are comunicated to explain how to register. Grades received during resits replace those from the first session.

Communication of results

Results communication schedule :

- 1st semester exams : mid / end of February
- 2nd semester exams : beginning of June for undergraduate courses / End of June for master's courses.
- Resit session :
 - Undergraduate courses : Mid-July

An official Transcript of records is available on the ENT as soon as the results are available. Later, a Transcript of records is sent to partner universities.
