International track for foreign students

Language of instruction: French

Admission requirements

- › Partnership agreement signed with the University of Bordeaux
- › French baccalauréat or high-school diploma
- › Certificate of French proficiency (TCF or DELF) B2 level of CEFR or higher

Program duration

- › Three years: 1st year of the bachelor degree (L1), 2nd year of the bachelor degree (L2), 3rd year of the bachelor degree (L3) divided into 2 different tracks: International and European law / Corporate law

Number of teaching hours

- › 1st year (L1) = 563 hours / year
- › 2nd year (L2) = 580,5 hours / year
- › 3rd year (L3) = from 451 to 531 hours / year

Program structure

- › First two years (L1 & L2) to acquire the fundamental principles of law
- › 3rd year: students are offered two different tracks in order to start their specialization :
 - International and European Law
 - Corporate Law

Program strengths

By sharing a core curriculum with the general bachelor degree program, this specific bachelor degree aims at improving the immersion of foreign students among local students. Foreign students are monitored by a team of dedicated professors who will help them adjust to the French cultural and academic system:

- › **Lectures** with students from the general bachelor degree program to acquire the fundamental principles of law
- › **Seminars** (TD) with students from the general bachelor degree program to acquire the fundamental principles of law
- › **Tutored assignments** (ED) for international students over the 3 years of the program (L1, L2, L3)
- › **French methodology class** for international students (L1)
- › **Specific law modules**: Law and society (L1), Comparative family law (L1), European and foreign constitutional law (L2)
- › **Foreign law modules**, taught by professors from partner universities
- › **French as a foreign language classes** (FLE), over the 3 years of the program

Assessment procedures

- › Continuous assessment: for seminars
- › Final examinations :
 - Written examination for modules including seminars (extra time, bilingual dictionary authorized)
 - Oral examination for modules without seminars

Program outline

Innovating program

The only program of this kind exclusively dedicated to foreign students in France. Bachelor degree in Law recognized by the French Ministry of Higher Education and Research

Program purpose

This tailor-made program, including an individual monitoring of the students, meets the expectations of our partner institutions by improving the integration and support of non-French speaking foreign students, coming from different cultural worlds and different legal systems (non-European)

Prerequisites

- French baccalauréat or high-school diploma
- Good spoken and written skills in French (B2 level of CEFR or higher)

Enrollment capacity

- › Depending on the number of students set in the partnership agreement signed with the University of Bordeaux
- › Depending on the number of applicants meeting the admission requirements

Mentoring program

- Tutored assignments (ED) for international students (10 hours for each module) to help them understand the fundamental concepts
- French methodology class (L1) to help the students understand and implement the methods of legal reasoning that are specific to legal studies in France
- Tutoring over the 3 years of the program to follow-up on the students' personal work, to help them prepare their weekly seminars and their oral examinations
- French as a foreign language classes over the 3 years of the program, to help the students acquire a good command, in French, of the legal concepts taught during lectures and seminars, whether orally or in writing, in order to prepare written or oral examinations
- E-learning English courses (optional)
- Foreign law modules taught by professors from our partner universities, enabling the students enrolled in the program to get a comparative approach with the own legal systems.
- Organization of meetings with law professionals (workshops, field trip visits) to bring a practical dimension to the concepts taught during the lectures
- Internships in L2 and L3 (optional)
